This Agreement, dated as of February \_\_\_\_ 2025, and is between \_\_\_\_\_ (“hereinafter referred to as Vendor”) and Delta Sigma Theta Sorority, Inc., Denton County Alumnae Chapter (DCA).

In exchange for vendor space at the Community Shopping Extravaganza in support of Black-owned businesses on February 22, 2025.

### Vendor agrees to the following:

- (1) Pay the vendor fee of \$100.00 on or before February 17, 2025.
- (2) Have the vendor table set-up between 10:45am-12:00 Noon
- (3) Have the vendor table cleared by (Take down is between 3:00pm-4:00pm)
- (4) Display *appropriate* items for sale or service at the event.

**(DCA reserves the right to ask any vendor to remove any items or information for services that is not considered appropriate).**

### DCA agrees to the following:

- (1) Provide access to set-up the vendor booth by 10:45am
- (2) Provide a vendor table and two (2) chairs for Vendor to display items.
- (3) Provide snacks and drinks for Vendor and one Guest.
- (4) Provide an opportunity for community/participants to visit the vendor booths.
- (5) Recognize vendors during the Event.

The parties agree that this contract can be canceled by either side upon written notice postmarked by February 17, 2025. Written notice will be considered delivered to the address or email address listed below. The parties agree that no request for refunds will be honored after February 17, 2025.

The parties further agree that in the event of cancellation of the Event for any reason, *if* the Shopping Extravaganza is not rescheduled, the vendor is entitled to a refund of half the vendor fee within 30 business days of the cancellation date.
